## **TX-UNPS** Activities

#### 2021 Texas Summer Mandate Notification and Waiver

Texas Legislation requires school districts in which 50% or more of the enrolled children are eligible to receive free/reduced price NSLP meal benefits to participate in a summer meal program based on the March 2020 claim. All mandated school districts received an email notification of their requirement as well as instructions for submitting their intent in TX-UNPS.



Please submit your intent for summer 2021 or submit a mandate waiver request in TX-UNPS by the **January 31**, **2021** deadline.

#### Updated Professional Standards Guide for School Nutrition Now Available



Team Nutrition has just released the updated Guide to Professional

<u>Standards for School Nutrition Programs</u>. This updated resource provides State and local school nutrition professionals a comprehensive guide to the required annual training and hiring standards under the Final Rule: Professional Standards for School Nutrition Programs Personnel. The updated guide addresses the additional final rule, published March, 1, 2019, that adds four flexibilities to the hiring standards for new school nutrition program directors in small local educational agencies (LEAs) and new State directors of school nutrition programs under the Professional Standards regulations for the National School Lunch Program (NSLP) and School Breakfast Program (SBP). The resource supports school nutrition professionals in ensuring they have the knowledge, training, and tools they need to successfully operate the NSLP and SBP.

## Compliance

#### **Financial Report**

The Texas Department of Agriculture (TDA) is releasing the National School Lunch Program (NSLP) Financial Report. This report is due **March 15, 2021**.



This report must be completed by Contracting Entities (CEs) who participate in the NSLP, School Breakfast Programs (SBP), School Milk Program (SMP) or At-Risk CACFP programs and must be completed by

an authorized representative. The NSLP Financial Report will not be available in TX-UNPS. An email with a jot form link for the *Preparing for the Financial Report* form has been sent to the Child Nutrition Director on the SNP Application.

The *Preparing for the Financial Report* form has been provided to prepare the CE in completion of the *NSLP Financial Report*. It contains a list of documents, terminology, object codes, and additional pertinent information related to the *NSLP Financial Report*.

Once the CE has completed review of this form and gathered the necessary documents, the CE will submit and will be directed to the *NSLP Financial Report* jot form.

CEs may also find PDF copies of the *Preparing for the Financial Report, NSLP Financial Report, and Excessive Fund Balance Plan*, the recording on the NSLP Financial Report training, and slide deck for the training presentation located on SquareMeals <u>here</u>

CEs may refer to Section 16 of NSLP Administrative Reference Manual (ARM) on <u>SquareMeals</u> for compliance guidance on financial systems information.

#### Excess USDA Foods Inventory

TDA created <u>USDA Warehouse Excess Inventory Flyers</u> highlighting the excess inventory (surplus food items) at your USDA warehouse as of January 2021. Each flyer lists USDA Food items available with corresponding USDA Recipes. Check surplus inventory weekly in TX-UNPS to see what additional USDA Foods you can receive for your district. As a reminder, the CF must have available entitlement to order surplus

#### **New Training Modules**

*Implementing and Operating the Community Eligibility Provision* is a new web-based training module that has been added to NSLP Online Training on SquareMeals. This training is for CEs that have elected to participate in CEP and provides guidance in the implementation process and changes to operations under CEP. Satisfactory completions of the course will provide 60 minutes of Professional Standards credit in the 3000 - Administration Training Topic.

*Calorie Requirements for School Meals and Commpetitive Food Sales* is an introductory module describes calorie requirements for the School Lunch and Breakfast Programs and food items sold in competition with reimbursable meals. This <u>course</u> provides .5 hours of Professional Standards credit.

#### New Food Buying Guide Features Now Available

New features released on December 11, 2020 are now available on the Food Buying Guide for Child Nutrition Programs (FBG). Team Nutrition appreciates receiving your feedback on the FBG and works continuously to enhance the user experience. Team Nutrition has further enhanced the capabilities for registered users by allowing Program operators the ability to create folders for the Recipe Analysis Workbooks (RAW) in the FBG Interactive Web-based tool. This new feature allows users to organize their RAWs using the Web-based Tool and also view them when logged into the FBG Mobile App. Additionally, users can now conveniently access their Favorite foods directly from the homepage with the new Favorite foods button on the FBG Web-based Tool.
