### **Urban Schools Agricultural Grant Program**

Urban public school districts with student populations of 49,000 or more are encouraged to apply for Texas Department of Agriculture (TDA) Urban Schools Agricultural Grants. The program provides up to \$2,500 each for elementary and middle schools' agricultural projects. Awarded funds must be used to establish demonstration projects or other projects designed to foster education, awareness, and appreciation of agriculture. Eligibility is also open to non-profits that have the support of a Texas public elementary or middle school in an eligible district.
